Notes/Narratives

NARRATIVE

While on patrol on 062410 at 0142 hours, I was flagged down by two males standing on Jackson Street at the entrance to the Administration Building. One of the males, Troxell, Gregory Raymond, stated he was walking near the Chapel on North Quad when he was forced to the ground, struck multiple times, and had 58.00 cash forcibly taken at approximately 0100 hours. Troxell stated he did not need medical treatment and declined to have EMS notified. There were no visible marks on Troxell. Detectives were contacted, and Troxell was transported to the University of Georgia Police Department to be interviewed.
