ACCUSATION

In the name and on behalf of the people of Athens-Clarke County, State of Georgia, Carroll R. Chisholm, Jr., as prosecuting attorney for Athens-Clarke County, does hereby charge and accuse **DARVEL NELSON** with the offense of **SIMPLE BATTERY** for that the said **DARVEL NELSON** on the 28th day of March, 2010, within the limits of Athens-Clarke County, did intentionally make physical contact of an insulting or provoking nature with the person of Meghan Vann by striking her, in violation of O.C.G.A. § 16-5-23,

**COUNT 2** In the name and on behalf of the people of Athens-Clarke County, State of Georgia, Carroll R. Chisholm, Jr., as prosecuting attorney for Athens-Clarke County, does hereby charge and accuse **DARVEL NELSON** with the offense of **SIMPLE ASSAULT** for that the said **DARVEL NELSON** on the 28th day of March, 2010, within the limits of Athens-Clarke County, did commit an act which placed Meghan Vann in reasonable apprehension of immediately receiving a violent injury, in violation of O.C.G.A. § 16-5-20,

**COUNT 3** In the name and on behalf of the people of Athens-Clarke County, State of Georgia, Carroll R. Chisholm, Jr., as prosecuting attorney for Athens-Clarke County, does hereby charge and accuse **DARVEL NELSON** with the offense of **DISORDERLY CONDUCT** for that the said **DARVEL NELSON** on the 28th day of March, 2010, within the limits of Athens-Clarke County, did act in a violent or tumultuous manner toward Meghan Vann whereby Meghan Vann was placed in reasonable fear of the safety of her life, limb and health, in violation of O.C.G.A. § 16-11-39,

**COUNT 4** In the name and on behalf of the people of Athens-Clarke County, State of Georgia, Carroll R. Chisholm, Jr., as prosecuting attorney for Athens-Clarke County, does hereby charge and accuse **DARVEL NELSON** with the offense of **SIMPLE BATTERY** for that the said **DARVEL NELSON** on the 28th day of March, 2010, within the limits of Athens-Clarke County, did intentionally make physical contact of an insulting or provoking nature with the person of Hutson Vann by striking him, in violation of O.C.G.A. § 16-5-23,

**COUNT 5** In the name and on behalf of the people of Athens-Clarke County, State of Georgia, Carroll R. Chisholm, Jr., as prosecuting attorney for Athens-Clarke County, does hereby charge and accuse **DARVEL NELSON** with the offense of **DISORDERLY CONDUCT** for that the said **DARVEL NELSON** on the 28th day of March, 2010, within the limits of Athens-Clarke County, did act in a violent or tumultuous manner toward Hutson Vann whereby Hutson Vann was placed in reasonable fear of the safety of his life, limb and health, in violation of O.C.G.A. § 16-11-39,
