NARRATIVE

On this date I was dispatched to 235 Highland Park drive in reference to Cruelty to Animals. Upon arrival I met with [REDACTED]. He advised me that he has a cat that had been hit with something causing it to have a laceration on the rear of the cat about 2 inch round. He then advised me that a kid named [REDACTED] that lived at [REDACTED] had been going around the neighborhood abusing cats. I then spoke to [REDACTED] that advised he was present and witnessed [REDACTED] throw a kitten against a tree killing it. He then said he watched him throw the kitten into the woods. [REDACTED] then took me to a location behind [REDACTED] Highland Park and showed me where the kitten was in the woods. [REDACTED] then told me that he also witnessed [REDACTED] kill another kitten and cut its head off with a butcher knife. That kitten was said to have been one of the kittens from [REDACTED] Highland Park drive as well.

I then spoke to the resident at [REDACTED] Highland Park Dr a [REDACTED]. She advised me that she would like to press charges on who ever had done this. She then advised me that several of the neighborhood kids told her that [REDACTED] was the one that had killed them. She also told me that he didn't live in the area all of the time just every now and then.

I was unable to locate the kitten that was said to of had its head cut off. The other kitten that was found in the woods was then turned over to Animal control.

Det Norris with Cid then arrived on scene. The case was then turned over to him. Det Norris also advised that he would enter the suspect information since he was going to meet with the suspect and his mother at PD.
